

Started in 1978, S&S Machine in Irving, Texas offers a full complement of CNC and manual equipment for sheet metal, milling, water jet cutting, industrial silk screening, and assembly requirements. Many of their major customers like Boeing and other aerospace suppliers have a high standard for quality documentation, such as AS9102B compliant FAIs. Recently we spoke to their quality manager about his decision to use InspectionXpert OnDemand and the results he achieved.

When Jimmy Dereta, joined S&S Machining as Quality Manager, he confronted significant challenges. FAIs were taking too long and the error rate was high. Simple FAI's were taking several hours, and more complex ones would take almost a full day. From years of manual FAIs, many FAIs were discovered with errors and mistakes back to 2005. As a result, several major customers were rejecting FAIs and placed jobs on hold until the mistakes were corrected. In addition to strained customer relations, the Quality Department was not running as well as it could with everyone consumed with, paperwork and dealing with customer reject issues.

Jimmy had seen InspectionXpert OnDemand software, and had heard about the benefits from other companies. While Jimmy considered other solutions, the ease of use and powerful features offered by InspectionXpert OnDemand was a major factor, in its selection.

The business case for InspectionXpert OnDemand is compelling.

Almost immediately, the time it took to create accurate and complete quality inspection documents was dramatically reduced, by as much as 75%. With most FAIs created with InspectionXpert OnDemand errors and omissions were almost totally eliminated resulting in FAIs accepted on first submission. S&S customers liked being able to review the electronic files prior to an onsite inspection, and relationships improved.

Prior to automating inspection planning with InspectionXpert OnDemand, S&S produced on average about:

- * 5 FAIs Per Day, or about 1250 FAIs per year
- * 5 hours per FAI (includes simple to complex FAIs)
- * 6250 hours per year (Hours do not include the time for error correction, rework, etc.)

Labor rates/Manual FAI labor costs:

- * \$100/hour
- * Total labor cost \$625,000 (\$100 x 6250 hours per year)

\$468,750 Savings with InspectionXpert OnDemand:

- * Reduced Time per required FAI by 75% (5 hours to 1.25 per FAI)
- * Reduced Labor cost \$468,750/Year (Labor cost of manual FAIs \$625,000 <less> Reduced labor cost of \$156,250/Year (1250 FAIs x 1.25/Hours = 1562.5/Hours/Year x \$100/hour = \$156,250)
